

Sub: Dispensation of conditions of applying Govt. Accommodation and furnishing of 'No Accommodation Certificate' for admissibility of House Rent Allowance - regarding.

Ref: MoF(DoE) O.M.No.2/5/2017-E.IIB dated 05/03/2019.

Govt. of India, Ministry of Finance, Deptt. of Expenditure, vide OM cited under Ref. above (copy enclosed) has decided to dispense with the conditions of applying for Government Accommodation and furnishing of 'No Accommodation Certificate' by Central Government employees to become eligible for House Rent Allowance, in respect of General Pool Residential Accommodation(GPRA) controlled by Directorate of Estates with a further authorization that Ministries/Departments having their separate pool of residential accommodation for their employees other than GPRA, may adopt these provisions, wherever feasible.

02. In view of the above, a Committee was constituted to examine the feasibility of adopting the aforesaid provisions for Government Accommodations of Ordnance Factories. Based on the recommendations of the said Committee and concurrence of Finance Division(OFB), DGOP & Chairman has approved for implementation of the provisions contained in MoF(DoE) OM dated 05/03/2019 dispensing with the requirement of NAC for grant of HRA.

03. Accordingly, it has been decided that the condition of applying for Government Accommodation and furnishing of 'No Accommodation Certificate' by employees to become eligible for HRA may be dispensed with and MoF(DoE)'s O.M. cited under reference above may be made applicable Mutatis Mutandis for Ordnance Factories employees with immediate effect.

04. All OFs/Units are, therefore, requested to follow the above guidelines in the matter of grant of HRA to their employees accordingly.


