Subject: Observance of "Sarkar Jagao Saptah" from 24-30 July 2020.

I hope all of you are quite well and busy in accelerating trade union activities and uplifting the organisation in your regions/ establishments and must be looking after your loved ones during this adverse time caused by Covid-19.

It is for your kind information that Bharatiya Mazdoor Sangh (BMS) has decided to observe Nationwide "Sarkar Jagao Saptah" (Government Awakening Week) from July 24-30, 2020 on problems of the workforce at National, State, Industry and Local Level. Sector-wise demonstrations will be held at State Capitals, District Headquarters, Tehsils/ Block Centres and also in all big Industrial Estates.

The Key/ Burning issues are-

- 1. Problems of unorganized Sector Workers particularly migrant workers issues.**
- 2. Non-payment of Wages.**
- 3. Huge Job losses.**
- 4. Suspension of labour laws and increasing of working hours in many States.**
- 5. Unbridled Privatization by selling PSUs and also through Corporatization of Defence and Railway Production Units.**

As a part of "Sarkar Jagao Saptah", members are required to contact grassroots level workers/ employees of each sector and educate them about the Central as well as State Governments' latest policies and their severe impact on labour and **expose the anti-workers Ordinances brought by 4 State Governments and increasing of working hours from 8 to 12 hours by 12 State Governments.**

For the above programme **each day has been allocated for a particular sector and July 27, 2020 has been allocated for Government Sector (Railways, Postal, Defence, Central Govt. establishments, Local Bodies, State Govt. employees).**

Government Employees National Confederation (GENC) vide its Circular No. GENC/ Cir/ 2020 dated 04.07.2020 has directed to all its constituents to observe demonstration, Sit-in, Rally,

whatsoever is feasible, in your establishments/ Units on 27th July 2020 and **submit memorandum to Hon'ble Prime Minister of India through respective HoDs or District Magistrate.**


