In turn OFB is communicating that a proposal has been forwarded to MoD with necessary recommendations of OFB but the matter is pending with MoD till date.

Therefore, you are requested to expedite the matter so that Durwan, Jamadar Durwan & Subedar Durwan may be granted financial upgradations in promotional hierarchy without further delay.

**5.XI.14.3 : Merger of the posts of Durwan and Jamadar Durwan with Subedar

STAFF SIDE BRIEF

As per the existing SRO for Durwans there are 3 categories of Durwan viz. Durwan, Jamedar Durwan and Subedar Durwan. Durwan is the feeder category for promotion to Jamedar Durwan and Jamedar Durwan is the feeder category for promotion to Subedar Durwan. Subedar Durwan is the feeder category for promotion to Supervisor (NT). 6th CPC has merged the Pay Scales of Durwan, Jamedar Durwan and Subedar Durwan and awarded the Pay Scale of Pay Band – 1 + Grade Pay Rs. 1800/-. Accordingly, as being done in the case of other categories wherever the merger of Pay Scale / post has taken place after the implementation of 6th CPC recommendations, the post of Durwan and Jamedar Durwan should have been merged with Subedar Durwan and all the Durwans should have been re-designated as Subedar Durwan. However, the same has not been done yet. Due to this the Durwans / Jamedar Durwans who have completed more than 20 years, are not getting their legitimate due of ACP/MACP. It is, therefore, demanded that the post of Durwan and Jamedar Durwan may be merged with Subedar Durwan and all the Durwans in the Ordnance Factories may be re-designated as Subedar Durwan w.e.f. 01-01-2006 as being done in the case of other upgraded categories.

The proposal has been forwarded to MOD with necessary recommendations of OFB.

MOD will be expedited for decision.

PRESENT POSITION

The matter is pending with MOD till date. Matter has been expedited on 07-06-2016.
