We have for reference the above wherein representatives of this Federation have been invited to attend the said meeting on 30.09.2019, but the agenda points are quite different.

An Oxymoron situation arose due to the following:

- a) While in the e-mail (ref (1) above), it has been categorically mentioned that the said meeting has been called to examine various aspects related to the proposed “restructuring” of OFB,
- b) Whereas in the letter (ref (2) above) it is mentioned that the meeting has been called to workout ways to “safeguard the benefits/interests of the employees in terms of wages, health facilities and other service matters etc. due to converting OFB INTO A PUBLIC SECTOR ENTITY.”

As a responsible stake holder, it is mandatory on us to have a clear understanding and vision of the agenda for constructive participation in the meeting so that a result-oriented discussion takes place.


Under such circumstances it is requested that MoD may immediately respond on the above aspects, to enable us to have better appreciation. MoD may clearly provide a

statement of intent on (1) Restructuring of OFB and (2) for conversion of OFB into PSE, clearly specifying objects, vision, viability aspects and long term perspective.
