Subject: Rationalization of Civilian Cadres in Indian Navy: Protest of. Reference: IHQ(Navy)/MoD letter no-CP(P&P)/4519/RC dated 31/Mar/2020.

Respected Sir,

With due regards, your kind attention is invited to the letter cited under reference whereby IHQ(Navy) has issued instructions on subject matter to all Command Hqrs seeking inputs on:-

- a) Cadre wise number of posts which may be abolished/reduced.
- b) Recommended merger and resultant increase/decrease in strength of respective posts in Cadre.
- c) Cadre-wise number of posts for which job responsibilities may be outsourced.

We all are aware that our nation as well as the whole world is battling with a catastrophic and unfortunate situation i.e. prevention of spreading of COVID-19.

To save the nation from the disaster, Govt of India has put the whole country under lock down till 14th April,2020.The whole Government machinery has been engaged at this time only to cope with prevailed havoc.

On the contrary, IHQ(Naval)/MoD has initiated the subject matter which is totally irrelevant to this time and trivial before prevailed situation. Further, the subject matter is totally concerned with the interest of employees, it should be discussed in JCM forum and views should be sought from recognised federations/ unions.

Therefore you are requested to look into the matter and issue necessary directives to the concerned authorities not to initiate the matter without obtaining suggestions from the recognised federations/Unions/JCM Members and the matter should be kept in abeyance till resumption of normalcy.
