Subject: Request to expedite the points raised in 24th Steering Committee meeting of JCM-III Level Council on 27.11.2020.

Sir,

With due regards, your attention is invited to the Minutes of the subject meeting circulated vide your letter No. CPT (JCM)/3543/XII/24th SCM, dated 29.01.2021 wherein following points were discussed: -

1. Cadre Review : The Chairman had assured that Cadre Review cases pertaining to fourteen cadres (Hospital Staff, Civilian Technical Officer, Technical Supervisory Staff and Artisan Staff, Library Staff, Armament Officer, Store House Staff, Scientific Officers and Staff and Hydrographic Officers Cadre, Printing Staff, Design Officers/Drawing & Design Staff and Cartographic Staff are under process at MoD for consideration/approval and are being accorded due priority for implementation at the earliest.
2. The four tier structure of Ammunition Mechanics has been introduced by Revised Recruitment Rules as notified and published in the Gazette of India vide SRO No. 111/2019 dated 17.12.2019 and the same has been communicated vide NHQ letter No. CP(NG)/2852/RR, dated 20.02.2020. But the newly created post of MCM could not be filled up till date, hence, it is being demanded that one time relaxation should be granted from the relevant provision of the SRO.
3. Minutes of the meeting reveals that the Points raised by Shri Shiv Karan Singh, BPMS in the 21st Steering Committee are still unresolved. For example – (i) Issuance of arrears to non-petitioners tradesman of batch No. 58 to 62 at ND(MBI), (ii) Payment of arrears of Non-Matric individuals recruits as MTS in ND(MBI) on or after 2008 were granted GP 1400/- and subsequently they were granted GP 1800/-.
4. Minutes of the meeting reveals that the Point raised by Shri Shiv Karan Singh, BPMS in the 23rd Steering Committee are still unresolved. For example – (i) Implementation of CGIT

award (CGIT-2/158 of 1999, Dated 13.06.2006) and Hon'ble High Court at the Judicature of Bombay order in WP No. 232 of 2008 dated 14.02.2008 regarding counting of casual period for pensionary benefit.

5. Shri Shiv Karan Singh, BPMS also raised a long pending issue of Cadre Review of Naval Aviation Cadre which is causing discontentment amongst the incumbents.

Therefore, you are requested to expedite the matters and to apprise with the current status of the above mentioned issues.
