APPEAL

Sub: Contribution to Prime Minister's National Relief Fund (PMNRF) : COVID-19 Epidemic – reg.

In the recent past Ordnance Factories have passed through very turbulent times due to various reasons. One of the disadvantages, which OFs have faced was due to the improper image regarding their products and performance. It was neither justified nor agreeable.

2. You all would agree that image building efforts of OF Fraternity through Newspapers, Media and TV channels etc in the recent past have been quite encouraging and its impact is becoming visible. Team OFB's effort to put up proper perspective in various high level meetings, have also been fruitful to build up our image.

3. The country is going through a humanitarian crisis of unprecedented magnitude in this critical hour of COVID-19 crisis. Many OFs (specially OEF Groups) have voluntarily come forward to rise to the occasion and have started working in 24x7 mode to establish production of Sanitizers, Face Mask, Coveralls/PPE etc to support the efforts of the Government to fight COVID-19. As a result of above efforts of image of OFs is improving.

4. Many forward thinking employees have spoken/messaged me that OF Fraternity should also exhibit its zeal to contribute to emergency Funds (like PMNRF), wholeheartedly and at better levels than other organizations. I am thankful for the enthusiasm and willingness shown by the representatives of various Federations/Unions & Associations to contribute towards this noble effort. Considering the strong feelings of my fellow employees and suggestions of many, I have agreed with the proposal of contributing TWO DAY salary (Basic) of all employees to PMNRF in this critical hour.

5. It is further suggested that in case the Salary Bill in respect of Officers/Staffs has already been passed by the LAO and the aforesaid deduction is not feasible at this stage, Sr.GM/GM/HoDs may make suitable arrangements for the equivalent amount in the form of a loan from other Funds, locally available.

6. Since the assistance is required immediately, the amount so deducted may be remitted directly to the PMNRF. It may be publicised that these contributions are elegible 100% deduction under Section 80(C) of the Income Tax Act, 1961. Details of remittance may be sent to: <u>ssharadrao.ofb@nic.in</u> and <u>p.surendran.ofb@nic.in</u>. <u>Press release on consolidated amount</u> <u>contributed by OFB will be issued centrally by OFB</u>. Unwilling employees may give a declaration to their respective Sr.GM/GM/HoDs on or before 06.04.2020.

7. Wide publicity to this appeal may be given by electronic means to all employees.
